2. **No conditional bid will be accepted.** The EMD will be refunded to the unsuccessful bidders as soon as practicable after a final decision has been taken on the Tender and to the successful bidders after furnishing the required Security Deposit for the contract.
3. **The intending Tenderer, in case of Prime contractor shall upload a self-declaration on their letter-head as PDF file in email of the tender, along with the tender documents, confirming that they are regular in performing similar works.**
4. The Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document/schedule and generally, they can be in PDF formats. Bid documents may be scanned with 100 dpi with black and white option.
